GLORY HAUS STANDARD TERMS AND CONDITIONS OF SALE

Payment Terms

The net amount of invoices shall be due and payable 30 days after invoice date. If Applicant fails to comply with the terms of payment or with any other terms of sale, Glory Haus shall have the right to withhold further deliveries or to cancel the unfilled portion of any order. Accounts past due or which have exceeded their credit limit may be placed on credit hold and may remain on hold until account status is within terms.

Any terms invoices that are paid with a credit card are subject to a 3% convenience fee that will be added to the total due at the time of payment.

Shipment

All orders will be shipped via Fed Ex Ground. If Applicant prefers, Glory Haus can ship via Fed Ex Ground Collect or UPS Ground Collect with a valid account number provided at time of order.

Claim Policy

Any claim for damaged, defective, shortages and overages of product must be reported to Glory Haus within 30 days of invoice date using the Glory Haus Claim Form which will be included with each shipment. This form should be emailed to: claims@gloryhaus.com.

AUTHORIZATION/AGREEMENT

By the signature of its authorized agent ("Agent") below, the entity identified as Applicant hereby
